HOUSE RULES

- 1.) Members are required to display a paid-up membership receipt upon demand of the Bartender or other person(s) so designated by the Board of Trustees.
- 2.) The Social Room will be open Monday to Friday 10:00AM to 10:00PM, Saturday 7:00AM and on Sunday 8:00AM to 10:00PM unless closed earlier at the discretion of the bartender on duty. These hours are subject to change based on business needs or state or federal requirements.
- 3.) Only members in good standing will be admitted to the Social Room. Delinquent members cannot be admitted as a guest of a paid-up member in the Social Room.
- 4.) Any member may bring in up to 4 guests without prior approval. All guests **MUST** be signed in by a member in the guest register. Members are responsible for the conduct of their guests while on Aerie premises, if the member leaves the guest must leave. If an applicant has been refused membership to the Aerie or Auxiliary he or she cannot be signed in as a guest. A non-member may come into the Social Room as a guest (3) times when accompanied by an Aerie or Auxiliary member in good standing, after which they **MUST** join the Aerie or Auxiliary (This rule includes spouses). The exception to this rule would be if a member has a guest visiting the area for no more than 45 days and who lives outside a 50 mile radius of Aerie 4089. Guests may play Bingo three times and must be signed in. All other games/machines are prohibited except for 50/50s, basket raffles, and lotto, etc. boards. (updated 2/3/25)
- 5.) Only members of the Aerie or Auxiliary are permitted to make alcoholic beverage purchases in the Aerie, **guests are not authorized to purchase alcoholic beverages.**
- 6.) Gentlemanly and ladylike conduct is always required of all persons in the Aerie. No person in a state of intoxication will be admitted. No profanity will be used at any time. **A Trustee or Bartender on duty is authorized to refuse service and eject anyone at any time.**
- 7.) All accusations and complaints must be made in writing, substantiated by witnesses, and must be made when the complainant is in a stable and sober condition. Any adverse or derogatory discussion at the Bar or in the Social Rooms of the Aerie concerning employees or the members of the Aerie will be deemed conduct unbecoming an Eagle and may result in the suspension by the Board of Trustees.
- 8.) Everyone must be properly attired to enter the Aerie. (No Shirt, No Shoes, No Service), No tank tops or sleeveless shirts may be worn by men after 4:30PM. *aguy*

9. You must be of legal drinking age (currently 21) as mandated by the State of Florida to be served alcoholic beverages or sit at the bar.
10. No alcoholic beverages will be allowed to be brought into or taken outside the building or fenced in area. No food or drink may be brought into the Aerie without prior permission from Trustees.
11. No one is allowed behind bars for any reason, inside and out, other than those authorized by the Trustees (or bartenders on duty for help as needed). The bartender on duty may select a person to help when service is needed. (updated 2/3/25)
12. Aerie or Auxiliary meeting business is not to be discussed in the Social Room at any time. All matters pertaining to the Aerie or Auxiliary shall be discussed only at a regular meeting. Any member violating this rule may be subject to suspension from the Social Room. Members will air their complaints with the Board of Trustees, not with the Bartenders or other employees.
13. No Smoking is permitted inside the Aerie or outside bar which includes electronic cigarettes, except in the smoking room or behind the building.
14. Animals are not allowed in our Aerie, except for Service Animals as defined by the ADA and Florida statute 413.08.
15. No checks will be cashed for non-members. All checks must be made out to Aerie 4089. Third party checks must be approved by a trustee. No checks made out to CASH will be accepted. A returned check fee of \$30.00 (Thirty Dollars) may be charged for each returned check. Any member having an unpaid check may be refused admittance to the social room until all fees have been paid in full. A maximum of \$200.00 may be cashed without prior approval.
16. Adults bringing children into the Aerie will be responsible to always supervise them and are not to be left unattended. Individuals under the age of 18 are not allowed to participate in raffles or other amusement games and are not permitted in the Social Room after 9:00 p.m.
17. For the purpose of safety and to avoid hazardous conditions no substances shall be applied to the dance floor and dancing is allowed only in designated dance areas.
18. Due to privacy concerns no photos or videos may be taken in Aerie without the bartender's or Trustees' consent.
19. The following House Rule infractions could result in a 90-day suspension and a possible recommendation to the Trial Board for expulsion. These actions could also result in criminal charges being filed.

Any physical altercation in or on Aerie property.

The sale, purchase or use of any illegal substance on the Aerie premises.

Anyone found stealing or deliberately damaging Aerie property.
